### What Information

- 1. What information do we collect?
  - 1.1. We collect information from you when you register on our site, place an order, subscribe to our newsletter, respond to a survey, fill out a form or Submit a support request or ticket.

- 3. How do we protect your information?
  - 3.1. We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers database only to be accessible by those authorized with special access rights to such systems, and are required to?keep the information confidential.
  - 3.3. After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be kept on file for more than 30 days.
- 4. Do we use cookies?
  - 4.1. Yes Cookies are small files that a site or its service provider transfers to your computers hard drive through your Web browser (if you allow) that enables the sites or service providers systems to recognize your browser and capture and remember certain information.
